CLFQP Kerbside Space and Road User Conflicts Survey Project

Providing agreement is received from the Steering and Administration Group later that day. It is anticipated a start will be made on the survey in early November and the selected road to be surveyed is likely to be in the Borough of Camden.

Members update/ any other business

- 1. Hugh Brennan gave an informative update on the Loading Bay "Marshalling". This project was successfully used during the Olympic period, because of this success it has been extended from August 2013 with a dedicated team. Members said from an operators point of view the scheme had worked well and welcomed the extension. A paper summarising this scheme will be provided by Westminster and circulated by Dennis.
- 2. Jerker Sjogren gave an outline of the Swedish Mobilization in Logistics and Transport "CLOSER". Confirming that they were looking at two Urban Transport Projects called GO:SMART and SENDSMART, giving an update on both. Jerker circulated a pamphlet on "CLOSER".
- 3. Members suggested an update on TfL on Cycling and associated road changes.
- 4. It was agreed the CLFQP would continue to meet four times a year.
