Item 1

Welcome, introductions and apologies.

Mike Browne welcomed everyone, introductions were made and apologies accepted.

Item 2 Notes of the last meeting (Current Freight Issues Group meeting of 19 March 2013).

The meeting notes were agreed.

Outstanding issues from the previous meeting:

- 1. A Meeting had taken place on Cycling and Kerbspace, this would be further discussed under item 6.
- 2. Mike Browne was still in contact with TfL on Cycling Superhighways.
- 3. Dennis has had no feedback on suitable projects from Boroughs for the CLFQP/LIP funding

All other items will be covered under the current agenda.

Item 3

Regional Freight updates (CRP)

Matthew Noon from Cross River Partnership gave an update on Regional Freight Projects. The items he covered were:

- The Mayor's Air Quality Results which are due out next week.
- Ultra Low Emission Zone (ULEZ) with a target date of 2020
- Responses from the April Public Health Survey produced the following results (in order of the importance of the health concerns):
- 1. Smoking
- 2. Air Quality
- 3. Alcoholism
- 4. Obesity
- 5. Road Accidents

There are already advantages of lower emissions with the new buses, and more improvement's planned for taxis.

A number of issues were raised by members:

- 1. Small business's may have difficulties with ULEZ and Boroughs will need to understand some of the issues for them.
- 2. Freight is diverse and there is no simple answer that "one size fits all solution".
- 3. Is Euro 5 fit for the ULEZ.
- 4. All of these issues and others need to be raised and resolved **before** consultation.
- 5. It was suggested that the ULEZ be raised at Ian Wainwright's Forum Meeting (24th June).

TfL Current Projects Update

Steve Steele gave an update on Freight Projects at TfL.

- "Safe Urban Driving Training", TfL has funding available from to support this initiative.
- The Freight Journey Planner user numbers are still being monitored.
- A Cycling Safety Event is being planned.
- To improve Freight/Cycling Safety, better training to be provided and bringing more "Fleets" up to the FORS "Gold" standard.
- TfL would like greater use of the 'Commercial Vehicle' FLAG for PCN hotspots (funding is available from LIP Funding).
- Out of Hours deliveries are to be extended with help from Boroughs.
