Item 5

Borough Initiatives and Issues on Freight

Uto Patrick from the Cross River Partnership (CRP) updated members on current CRP projects:

Delivery Servicing Plan review work is well under way. CRP together with TfL have reviewed over 30 DSPs, going back over the past 5 years, that have been required through the statutory planning process in City of London. They are producing guidance for both businesses needing to prepare a DSP, and providing support to local authorities required to review DSPs, and rolling out some training by the end of the year.

Links to other last mile delivery initiatives currently being planned in Central London. The CRP are working with other stakeholders to identify and share information about all the current last mile delivery initiatives currently underway or being planned in central London, including a number of the Business Improvement Districts: Baker Street Quarter, New West End Company for Bond Street, and The Fitzrovia Partnership.

Energy Savings Trust(EST) have funding available to work with up to 35 fleets in the capital to help them determine where cost-effective opportunities lie for acquisition of plug-in vehicles and how strategically located rapid charging infrastructure can maximise these opportunities. Participating fleets will also benefit from free analysis of their operation from scheduling and optimisation experts Route Monkey. Item 6

TfL Projects update/progress

Tim Ward gave the following update on current projects and issues at TfL

Consultations on Cycle Superhighways

TfL are keen to hear the detailed views of stakeholders on proposals. Their plans are not set in stone and can be amended following consultation. This has already happened in the case of CS5 along the Harleyford Road and this is now being consulted on (see below).

Although the official consultation for CS NS/EW and CS2 Upgrade are now closed, submissions from key stakeholders will be accepted until 30 November. Tim committed to circulating the minutes of the meetings held so far (which has now been done).

The Freight and Fleet team recognise we have more to do to educate colleagues designing these schemes about the needs of freight.

In order to design the best possible schemes TfL need to understand the views of a range of stakeholders, including the freight industry.

Dennis updated the members with the current position of this Project, confirming the project was complete and the full report had been issued to all members of CLFQP.

Consultations on Cycle Superhighways

Mike Bracey started the discussion by listing the following main concerns he and other Industry members had with the 2 major Superhighways being consulted on (CS2 (Whitechapel Rd, Mile End Rd and Bow Rd) and N/S - E/W)

Loading bays disappearing Junction closures Red Route changes Increased travel times LLCS Review Street furniture review Disruption during implementation

Mike Bracey asked TfL to ensure essential kerb space is not removed or reduced. Also suggesting TfL might not be communicating in the right format as many industry operators do not attend the consultation meetings and this needs attention.

After a general discussion, Tim Ward understood the issues raised and assured the meeting that those raised and others were being very carefully looked at. Tim would ensure the Freight industry would be kept fully briefed

on this very important subject, but suggested Freight operators should respond direct to TfL on this consultation.

Natalie asked members to pass to the FTA any data on estimated increased journey times.

Antoneta Horbury confirmed Kensington & Chelsea will shortly be operating a trial/pilot using pay by phone for street parking.

Keith Abbott raised the subject of driver shortage in London (HGV). Members suggested this subject should be included in the next CLFQP agenda. (24th February 2015)
