Item 1

Welcome, introductions and apologies.

Outstanding issues from the previous meeting: Baker Street 2-way scheme

Item 3

Presentation on the CITYLAB Project

Julian Allen and Sam Clarke gave a presentation on this, highlighting the issue of logistics and land availability in Central London.

Item 5

Cross River Partnership projects (CRP)

1. Oxford Street West Business Engagement Research

Vicky Keeble gave an update on this project and asked if logistics operators could provide help with the Oxford Street West Freight research, which CRP has been commissioned to do by Westminster City Council.

Vicky Keeble also briefed the group on this project and requested members to contact CRP with any schemes they know which may improve the "collect" option listed in the scheme.

3. Freight TAILS Update

The current position with this project was discussed confirming the next theme would be related to "integration". The CRP would like CLFQP members to consider "what motivates change" in the area of integration and send any comments to Dennis.

Item 6

Borough initiatives and issues on Freight

Kevin Burke confirmed the London Borough of Southwark was looking at:

- 1. "Planning" relating to Loading bays/Taxi ranks
- 2. London Bridge area.

Antoneta Horbury noted that Kensington and Chelsea Council had launched a consultation on the Sloane Street Public Realm Scheme. Adding that Kensington and Chelsea Council had also started their borough wide roll out of the Paybyphone parking system.

Antoneta has emailed Dennis details of how companies can obtain Corporate Accounts for Paybyphone and she encouraged members to take up this facility if possible as the pay and display machines do not accept card. (Details below)

Hugh Brennan from Westminster City Council (WCC) noted they have £20,000 LIP funding for Freight, and re-confirmed the the Baker Street two-way scheme details would be circulated as soon as they are available.

Tom Parker from the City of London, confirmed that they are looking at all aspects of Freight in the City, and as soon a clear strategy becomes available it will be shared with the group.

Sarah Finn from the London Borough of Lambeth noted they were looking at Loading/Parking bay use. Along with a review/consultation of the "Imax" area.
