Denise Beedell confirmed a report by London councils had been issued listing recommendations on the London Lorry Control Scheme. Many points had been agreed (although not all members of the review group agreed with all the recommendations). Denise would give a further update at the next CLFQP meeting.

#### Item 3

#### **TfL Projects update**

Tim Ward gave an update on the following TfL projects.

- The Draft Mayor's Transport Strategy has been issued, with a number of sections covering Freight. A precis paper highlighting Freight will be issued by Tim for circulation. (subsequently TfL have reconsidered this and members should read the whole document rather than the Freight elements only)
- 2. A Special Freight Forum meeting is to be arranged within the next 4 weeks (the date now agreed is the 27<sup>th</sup> July)
- 3. The Air Quality/Ultra Low Emission Zone (ULEZ) consultation results were being evaluated.
- 4. Direct Vision Standards (DVS) consultation.

Some Industry members were concerned with the deadline on DVS because of the lead time required for replacement vehicles.

#### Item 4

### **Oxford Street Transformation Project**

Sarah Rye from Westminster City Council (WCC) gave an overview of this project confirming it had a tight timescale with large implications for the Freight industry. A number of meetings had already taken place with stakeholders.

The CLFQP offered to help with arranging any further meetings with Freight stakeholders. These could be held at the University.

#### Toby Jacobs. (WCC)

Westminster were looking at Micro Consolidation, if there were results from this work Toby would liaise with Dennis for general circulation.

The Borough were just starting Business engagement on their Low Emissions Project.

#### Antoneta Horbury (Royal Borough of Kensington & Chelsea)

## Members update / any other business

Sam Clarke raised the issue of new Minimum charges set by TfL relating to Electric Vehicles.

Mick Dearle supported the view that early notification is essential on both the ULEZ and DVS for industry to make changes to commercial fleets.

Denise Beedell confirmed the FSB will be using the FSB website to distribute their Newsletter.

Julia Allen informed members a follow-up document is to be issued by the end of August on "Logistics land availability in Central London".

Dennis again raised the issue of **Loading/unloading regulations across all London Boroughs.** Further information has now been received from London Councils confirming that an additional 5 more boroughs had replied, these were:

- Westminster
