Item 4**TfL Projects update (including “Re- Timing Deliveries”)**

Jaz Chani gave the following update:

General update

TfL are preparing for the outcome of Thursday's election. All candidates have said something about freight, a first for a Mayoral election. Safer lorries, better air quality and reduced congestion are all mentioned in manifestos but only one candidate has mentioned an out and out lorry ban. In the meantime, TfL are keeping up business as usual, working with partners on retiming, consolidation, safety, LoCITY, air quality and engaging with industry, boroughs and businesses. It will be possible to say much more at the next CLFQP meeting as any new direction of travel will be clearer by then.

Retiming update (presentation attached)

There has been significant progress with the Retiming Deliveries programme. Having demonstrated the collaborative approach to changing delivery times for difficult sites, the Consortium is now expanding the approach with other organisations through working groups. The programme will now focus on area-based schemes to demonstrate wider environmental benefits and drive more change through the communications campaign and the TfL matchmaking service.

CLFQP members can get in touch with how they can help.

Two issues raised by members:

1. Could TfL give some financial help to assist Boroughs in application/implementation of these projects?
2. With these and any changes TfL must ensure that they are “joined up” across Boroughs and projects.

Item 5

Borough initiatives and issues on Freight

Sarah Rye (WCC) gave a detailed report of the The West End Partnership (WEP) vision statement and delivery plan. Sarah confirmed this project was in its early stages, but was hoping for full funding in the autumn 2016.

A full and comprehensive summary of the WEP Freight Plan is attached.

Antoneta Horbury noted that RBKC would soon be consulting on a proposed width restriction on Clareville Grove (post meeting note: AH circulated details to all CLFQP members on 6 May). AH also said that they may be proposed changes to loading restrictions on Kensington High Street, if businesses confirmed that this would not negatively impact them (post meeting note: the Kensington High Street proposed changes were not advertised so no changes will be made to the loading restrictions on Kensington High Street).

Hugh Brennan confirmed the development of a WCC draft “walking” strategy document. This could have ramifications on kerbside use.

Dennis agreed to circulate the FTA London Election Manifesto, supplied by Natalie Chapman.

Action: Dennis to circulate the FTA Manifesto.

Mike Bracey raised the issue of “Kerbspace - the future of Freight in London”

After a general discussion the group suggested Dennis should write a short paper to Ian Wainwright with CLFQP concerns and asking if he would address the subject at the next meeting.
